I. Allgemeine Informationen

Das Hongkonger Rechtssystem stammt aus der britischen Kolonialzeit und beruht auf dem „Common Law“. Es unterscheidet sich dadurch grundlegend von dem Rechtssystem Festlandchinas. Vor den Gerichten herrscht kein Anwaltszwang, sodass mündige Personen selbst vor Gerichten auftreten können. Allerdings kann bei der Vorbereitung von bestimmten Dokumenten die Hinzuziehung eines Anwalts nötig sein. Vor dem Small Claims Court (Streitwert unter 50.000 HKD) ist die anwaltliche Vertretung sogar gesetzlich untersagt. Angeklagte in allen Strafsachen, die sich keinen Rechtsanwalt leisten können, können Prozesskostenhilfe beantragen. Auch in Zivilsachen können Kläger oder Beklagte bei unzureichenden finanziellen Eigenmitteln einen Antrag auf Prozesskostenhilfe stellen. Die Anwaltschaft unterhält eine Beratungsstelle (www.hkba.org).
