## Schengen Visa for Domestic Helper

This is the right visa to apply for if you wish to accompany your current employer to Germany for up to 90 days in 12 months.

## Please be informed that the German Consulate General cannot proceed Schengen visa for Domestic Helper for Portugal and Slovenia.

## **General Information**

- The visa application can be submitted at the earliest six months prior to the planned trip.
- Documents that are not issued in German or English must be submitted together with a translation.
- Each visa application is reviewed individually. Therefore, the requested documents might vary. The Consulate General reserves the right to request further documentation.
- Submission of an incomplete application may lead to a refusal of your visa application.
- The standard processing time is approx. 5 10 working days upon submission of complete documents.

## Proof of travel health insurance stating

- name of the applicant
- coverage of at least 30.000 EUR for medical expenses and repatriation
- valid for the entire Schengen area
- valid for the entire duration of stay in the Schengen area

□ Visa application fee

- 90 EUR, for applicants 12 years and older
- payable in cash in HKD only (exact amount in HKD depends on the exchange rate)
